

My Bet Funding Terms and Conditions

Welcome to mybetfunding.com. The website and all associated services offered by LNV TRUCKING LLC (collectively referred to as the "Site") consist of various web pages managed by My Bet Funding. Access to this Site is granted based on your acceptance of and compliance with the terms, conditions, and notices detailed here (collectively known as the "Terms" or "Agreement"). - Engaging in picking during times of high volatility
- Hedging between My Bet Funding accounts and/or external accounts

Any breach of these Terms or applicable laws, regulations, or standards may lead to the immediate closure of all accounts associated with our services, without any refunds or payments issued. Furthermore, you could be subject to civil and/or criminal penalties if you violate these Terms or relevant laws. Acknowledging the need for a secure and dependable trading environment, you explicitly authorize My Bet Funding to share your information with other proprietary trading firms or third parties for the purpose of identifying fraudulent, deceptive, or criminal behavior, as well as any breaches of our Terms or this Agreement.

Indemnification
